M/S/P Wachal/Luepke to keep the budget the same in 2022 as in 2021.

PACE: This committee did not have much to report, but Robin is always willing to report if needed.

Legislative Committee: Chair Metz notified the board that Fryberger will present at the November meeting. He also brought up the issue that Stearns county presented at AMC that they have many solar

projects that are less than 1 MW. These projects do not any additional tax revenue to the county, which is their concern. They would like the property to be taxed at the commercial rate. At the November meeting, the board will discuss this issue in more detail.

SW CERT: Also, CERTs is seeking applications for the latest round of Seed Grants. Organizations have until October 8 to apply. To get more information and/or to apply, people can visit https://www.cleanenergyresourceteams.org/seedgrants

Also, there is \$16 million allocated for Solar on Schools - \$8 million in Xcel territory and \$8 million to the rest. The rules are still being written, but the Xcel projects can be for up to 1 MW, while the other projects will be up to 40 KW with the requirement that solar be implemented in the curriculum and that a monitor with real-time reporting be visible inside the school.

OTHER BUSINESS AND REPORTS: Vince Robinson brought up proposed federal legislation that would provide incentives to building renewable energy that would include giving 85% as direct payments at the LLC level instead of as tax credits. He said this change would bring a lot more players to the renewables market.
